Applications are reviewed and rated by the Grants Committee and the Board of Directors in terms of:

- Capacity and ability to successfully manage funds and execute the proposal.

Specific criteria are used to evaluate the merits of each proposal, and may include that the organization and/or proposal:

- Meets a current community need and is feasible as presented.
- Generates the biggest multiplier effect, creating a positive ripple effect for human and/or social gains.
- Leverages other funds.
- Encourages and involves volunteers.
- Encourages collaboration with other organizations.
- Provides vital assistance within the Northfield community to sustain a thriving, equitable community for all residents.

The deadline for application submission is **October 4, 2024**. Applicants will be notified in November of decisions, with funds being disbursed in December.

If you received grant funding in 2023, your [Final Impact Report](#) is due September 30, 2024. This report allows us to acknowledge the work you are doing, and to share stories and information with stakeholders and donors about the impact these funds are making in our community. Photos to support the report are highly encouraged.
